# A RESOLUTION ACCEPTING BID AND ISSUING NOTICE TO PROCEED TO CONSTRUCT THE ANDERSON-COTTONWOOD IRRIGATION DISTRICT EMERGENCY CANAL LINING PROJECT

WHEREAS, on June 15, 2023, the Board of Directors of Anderson Cottonwood Irrigation District (District) adopted Resolution 2023-3 that, among other things, determined that emergency conditions existed within the District's service area related to high groundwater conditions; and

WHEREAS, on September 14th, 2023, the District published an invitation to bid on the District's Emergency Canal Lining Project (Project); and

WHEREAS, on September 26, 2023, the District received xx bids from contractors biding on one or more segments of the Project; and

WHEREAS, the District's staff and engineers have reviewed the bids for consistency with the District's bid requirements and specifications; and

WHEREAS, the Board of Directors finds that the Project is consistent with and covered by the notice of exemption filed under the California Environmental Quality Act (CEQA) on or around July 25, 2023 and designated as state clearinghouse number 2023070533; and

WHEREAS, the Board of Directors finds that the Project is in the best interest of the District and its landowners.

# NOW, THEREFORE, BE IT RESOLVED:

- 1. All of the foregoing Recitals are true and correct and are incorporated herein as findings of the Board of Directors.
- 2. The Board of Directors accepts the bid of [contractor] and by this Resolution authorizes a notice to proceed effective October \_\_\_\_, 2023 for [describe approved segments & scope of work to be performed by contractor].
- 3. The Board of Directors authorizes and directs the District's General Manager to:
  - a. Execute all necessary documents, including the construction contract with the selected contractor;
  - b. Amend the current budget to authorize the expenditure of District funds consistent with the selected contractor's bid and the District's contract documents; and
  - c. Take such other reasonable and necessary actions to timely and satisfactorily complete the Project.
